The college also has a moderate library and actively promotes exploratory and participatory learning. Moreover, college emphasizes continuous internal evaluation through assignments, unit tests, seminars, presentations, and projects, overseen by an examination committee. Alongside academic initiatives, the college's active RED CROSS unit participates in blood donation camps and government medicine distribution programs, contributing to holistic student development. The college curriculum prioritizes essential crosscutting issues such as professional ethics, gender sensitivity, human values, and environmental sustainability across its faculties. Voter literacy campaign committee involves in awareness programmes in the community. College also maintains Eco-club to sensitige the students regarding environmental awareness.

The enrollment of the students into first year of UG Courses increased from 30% to 70% from 2017-18 to 2022-23. Reservation policy of the state government is applied to fill the seats. Two class rooms are fitted with projectors to deliver lectures. This is also supported by a mobile handy projector to use by all the teachers. First-year students in all streams undertake projects in Environmental Science, while third-year BA Geography students carry out socio- economic surveys in designated study areas. Regular debates, quizzes, and seminars are organized on relevant topics, contributing to the all-round development of students. Classroom presentations enable them to receive questions from peers, thereby deepening their understanding of the topic. It provides them with experiential learning and helps them to develop their personality. NSS volunteers actively engage in community-based initiatives such as the Swachh Bharat Mission and AIDS awareness campaigns. N List is resource software used for library seats. SOUL Software is equipped in the library to maintain the library and is in use. The library has a collection of total of 5450 books and a seating capacity of 50.

As the part of internal assessment various class tests, unit tests, quarterly tests and midterm tests to evaluate students are conducted. Departments give students home assignment and conduct practical examinations. Remedial Classes are conducted for improvement. There is Internal Grievance Redressal Cell also.

The programme and course outcome are uploaded on the college website to make the student aware. Faculty takes efforts in explaining course out comes to the admission seekers. Programme and course outcomes are explained to student during orientation and also discuss in their respective classes at the commencement of each year by teachers. There are 13 departments each with only one full time teacher. There are only 10 class rooms to conduct theory classes. There is shortage of space and college needs some more class rooms and additional space for laboratories.

The workhorse of the Institution is their Cultural Committee that engages all the events and ensures the participation of each student throughout the academic year. Institution keeps a pace with the parallel world and therefore puts a strong emphasis on sports activities. It helps students in building their character, mental health and ensures in them leadership and team-work capabilities. Institution is sportily active in organizing various competitions for students such as singing, dancing, elocution, debate, dramas, mimes, contests, and so others that help to provide an active environment for fostering students' appetite and acknowledge their talent. The institute provides programmes of Skill Development and Training. All this was evident from the performance of students during the cultural evening on first day of visit. The institution proactively involves and provides support for research which ensures the involvement of faculty members in various orientation programmes, webinars, seminars, conferences, and workshops. The faculties are actively published their research papers in various journals including UGC Care listed journals and SCOPUS. The faculty has published in total of 20 publications in peer reviewed journals, ten book authored and one book chapter. One teacher also own a patent from Australian Government. The college entered into 2 MoU's and one collaboration which are active. Student's participation is also encouraged through projects, surveys, educational tours, etc. Funds are timely provided for the improvement of the research and development. With the help of NSS along with the English Literary Club, the institution seamlessly engages students in social activities to help them building their character and nature. College NSS unit has successfully organized extension activities within the local community, addressing crucial social issues and imparting ethical values. The units's exceptional performance has gained recognition at the university level, while SWEEP program and collaborations with organizations like RED CROSS have enhanced impact of the college.

The college has facilities like 11 classrooms equipped with green boards and podiums etc., besides, has 5 laboratories in different subjects and a computer lab having 10 computers, printer and photocopier. Library is fully automated with recently procured SOUL 3.0 software featuring barcode scanning for efficient management. College is having seminar hall with a seating capacity of 200 equipped with digital projector and sound system. College is having NSS room and sports room for games facilities. There are girls common room in the college and 4 separate playgrounds for cricket and football, volleyball, kho-kho, kabaddi and badminton. There are open yoga classes facility for students and employees. The library has an active N-LIST subscription, granting access to an extensive collection of e-books and e-journals. Both staff and students have the privilege of utilizing these valuable e-resources through the N-List platform. The library also houses a substantial physical collection, with approximately 5450 books available for students and faculty. The college relied on traditional modems for internet connectivity until 2019. To meet the growing demand for better and faster internet access, the college upgraded to a BSNL Wi-Fi connection. To promote digital literacy and ensure equitable access to technology, the college participated in the "Sanchar Kranti Yojna" initiated by the state government. Though the greenery is limited, college trained students the techniques of creating QR codes to each plant/tree with the help of Botany department and QR codes are displayed.

Qualitative analysis of Criterion 6

The college adopts a decentralized governance system by granting operational autonomy to different functionaries These include the Internal Quality Assurance Cell (IQAC), Admission Committee, Time-Table Committee, Examination Cell, Scholarship Committee, Grievance Redressal Cell, Cultural Activity Committee, Sports Committee, Women Cell, Youth Red Cross (YRC)/N.S.S Committee, Career Counseling and Placement Committee, among others. The college has developed short-term and long-term Institutional Perspective Plans to guide its growth. The short-term plan focuses on immediate goals like improving infrastructure and academic programs, while the long-term plan encompasses broader aspirations such as

expanding programs. On the other hand, the JBS appoints employees for fixed periods during each session for non-teaching and other related roles. The promotion of employees follows the state government's rules. To address any grievances raised by teachers, employees, or students, the college has established a complaint resolution mechanism. CCTV cameras are strategically placed throughout the campus, promoting security and monitoring.

Class III and IV employees receive grain provisions, advances, and travel allowances to meet their specific needs. Percentage of teachers provided with financial support to attend conferences/workshops and towards membership fee of professional bodies during the last five years is fairly good. Regular financial audits are conducted internally and external audit is pending for long time. The institution receives funds from various sources, such as state government, RUSA (Rashtriya Uchchatar Shiksha Abhiyan) and JBS (Janbhagidari Samiti), as well as donations from individuals and entities. The IQAC, staff council and student union propose the necessary funds required for teaching and other activities. Maintenance and repair work within the institution is assigned to the Public Works Department (PWD) the IQAC has organized webinars, seminars, and COVID vaccination drives, while establishing collaborations with other institutes through Memorandums of Understanding (MoUs) and initiating vocational training programs for students. The IQAC Cell of Government College Bishrampur played a vital role in ensuring and enhancing the quality of education provided by the institution. Strategic planning is crucial to the work of the IQAC, which assigns responsibilities for key areas such as academic results, soft skills development for students, laboratory improvements, career guidance, seminar and conference participation, vocational courses, library updates, and rainwater harvesting implementation. Feedback from stakeholders, including students, teachers and alumni, is actively collected and analyzed during the annual strategic planning process. Though feedback analysis is not extensive IQAC has sincerely collected responses, analyzed statistically and arrived at conclusions that is appreciable.
